

# ROTTERDAM-MOHONASEN CENTRAL SCHOOL DISTRICT

## *Minutes of Annual School District Meeting Tuesday, May 15, 2007, High School Gymnasium*

The meeting was called to order at 6:50 AM by Mrs. Denise Swezey, District Clerk, who asked the inspectors to inspect the voting machines to be used for voting and sign the required affidavits. The polls were declared officially opened at 7:00 AM.

At 9:00 PM Mr. David McNamara, Permanent Chairman, declared the voting to be ended and the voting machines were opened and inspected; absentee ballots were opened and tallied. The inspectors officially certified the following results:

Shall the following resolution be adopted, to wit:

RESOLVED, that the Board of Education of the Rotterdam-Mohonasen Central School District, Towns of Rotterdam, Schenectady County, and Colonie and Guilderland, Albany, County, New York, be authorized to expend the sum of Forty Million, Two Hundred Ninety-Seven Thousand, Three Hundred Seventy Dollars (\$40,297,370.) for school purposes during the 2007-2008 school year and levy the necessary tax therefore.

### *Proposition One- Buses:*

Shall the following resolution be adopted, to wit:

RESOLVED, that the Board of Education of the Rotterdam-Mohonasen Central School District, Town of Rotterdam, Schenectady County and Colonie and Guilderland, Albany County, New York, be authorized to pay the cost of the purchase of school buses of and for said School District, including incidental improvements and expenses in connection therewith, at a maximum estimated cost of Four Hundred Thirty Thousand Dollars (\$430,000.), and providing for the levy of a tax therefore to be collected in installments, with obligations of said School District to be issued in anticipation thereof in an amount not to exceed Four Hundred Thirty Thousand Dollars (\$430,000.)

Mr. Cafarelli and Mr. Macejka will serve three-year terms from July 1, 2007 until June 30, 2010.

MOTION made by Mr. Lee French, seconded by Mr. Joseph Salamone, that all proceedings of this Annual School District Meeting be ratified and confirmed, to wit: the proposed budget for the 2007-2008 school year in the amount of \$40,297,370 was approved, the expenditure of \$430,000 for the purchase of buses was approved, and Dominic Cafarelli and Charles Macejka were elected to the Board of Education. The motion was approved unanimously by all those present, approximately twenty-five district residents.

MOTION made by Ms. Susan Baker, Tower Avenue, seconded by Mrs. Helen Pugliese, Cox Avenue, that the meeting be adjourned at 9:20 PM.
