*Minutes of Annual School District Meeting
Tuesday, May 15, 2018 – High School Gym*

The meeting was called to order at 6:59 AM by Mr. James McCrum, Permanent Chairperson, who asked the inspectors to inspect the voting machines to be used for voting and sign the required affidavits. The polls were declared officially opened at 7:00 AM.

At 9:00 PM Mr. James McCrum, Permanent Chairperson, declared the voting to be ended, absentee ballots were opened and scanned, and the voting machines were inspected and closed. The inspectors officially certified the following results:

Shall the following resolution be adopted, to wit:

RESOLVED, that the Board of Education of the Rotterdam-Mohonasen Central School District, Towns of Rotterdam, Schenectady County, and Colonie and Guilderland, Albany County, New York, be authorized to expend the sum of fifty-three million sixty five thousand dollars (\$53,065,000) for school purposes during the 2018-2019 school year and levy the necessary tax therefore.

Proposition - Buses:

Shall the following resolution be adopted, to wit:

RESOLVED, that the Board of Education of the Rotterdam-Mohonasen Central School District, Towns of Rotterdam, Schenectady County, and Colonie and Guilderland, Albany County, New York, is hereby authorized to pay the cost of the purchase of school buses of and for said School District, including incidental improvements and expenses in connection therewith, at a maximum estimated cost of four hundred seventy thousand dollars (\$470,000.00) and providing for the levy of a tax therefore to be collected in installments, with obligations of said School District to be issued in anticipation thereof in an amount not to exceed four hundred seventy thousand dollars (\$470,000.00).

Patrick Ryan, Pamela Young and Wade Abbott will serve three-year terms from July 1, 2018 until June 30, 2021.

MOTION made by Mr. Ryan, seconded by Ms. Young, that all proceedings of this Annual School District Meeting be ratified and confirmed, to wit: the proposed budget for the 2018-2019 school year in the amount of \$53,065,000 was approved; the expenditure of \$470,000 for the purchase of buses was approved; and Patrick Ryan and Pamela Young were re-elected and Wade Abbott was elected to the Board of Education. The motion was approved unanimously by all those present, approximately 7 district residents.

MOTION made by Mr. Ryan, seconded by Ms. Young, that this special meeting be adjourned at 9:21 PM.
