#### Summary & Background

On March 11, 2021, President Biden signed into law the American Rescue Plan (ARP) Act of 2021. The ARP Act included an unprecedented \$800 million reservation within the Elementary and Secondary School Emergency Relief (ESSER) Fund to support the specific and urgent needs of homeless children and youth in recognition of the extraordinary impact of the coronavirus disease (COVID-19) pandemic on students experiencing homelessness. The Department is administering these funds through the ARP Homeless Children and Youth (ARP-HCY) Fund.

The ARP-HCY fund was created for the purposes of identifying homeless children and youth, providing wraparound services in light of the impact of the COVID-19 pandemic, and providing assistance needed to enable homeless children and youth to attend school and participate fully in school activities, including in-person instruction this spring and summer learning and enrichment programs.

After reserving \$1 million of the \$800 million (0.125 percent) for national activities including technical assistance, the USDE awarded the remaining \$799 million to State educational agencies (SEAs) as follows:

\$199,750,000 (25% of the \$799 million) was made available to States immediately. NYSED received approximately \$14,720,327 in this disbursement. This disbursement was designed to provide funding to States immediately as a supplement to their McKinney-Vento Education for Homeless Children and Youth HCY funds, so that States can address urgent needs of homeless children and youth—including academic, social, emotional, and mental health needs—and so States and local educational agencies (LEAs) can increase capacity by hiring staff, dedicating resources, and planning partnerships with community-based organizations, among other strategies. Funds must be administered by the Office of the State Coordinator for the Education of Homeless Children and Youth, consistent with the requirements for HCY funds. These funds were disbursed to eligible LEAs through the ARP-HCY Part I Application issued in November 2021

\$599,250,000 (75% of the \$799 million) was made available to States after submitting the required application to USDE. Upon approval of New York's State Plan by the USDE, NYSED received approximately \$44,190,109 in the second disbursement. States are required to distribute the funds they will receive in the second phase to LEAs via a formula that uses the LEA's allocation under Title I, Part A (Title I) of the Elementary and Secondary Education Act of 1965 (ESEA) and the number of identified homeless children and youth in either 2018-19 or 2019-20, whichever was greater.. #### Timeline

Funds appropriated under the ARP-HCY program will be available for obligation until September 30, 2024.

- Work with community-based organizations for this purpose, as well as to provide wraparound services to these students.

These activities may include any expenses necessary to facilitate the identification, enrollment, retention, and educational success of homeless children and youth.

We intend to work with community based organizations along with addressing defined needs of our students on an individual basis. This will be accomplished by the following:

Mohon Cares: Anchor Rooms: Each school has a room where K-12 students can receive free clothing and toiletries: an Anchor Room at Bradt Primary and Mohonasen High School, the Next to New Closet at Pinewood Intermediate and the Draper Closet at the middle school. Each of these programs exist because of donations (monetary, clothing, shoes, toiletries, etc.) through each school's community and staff, and they are always requesting more. The figures are tallied from the Anchor Room Sign-Ins for the 2018-19 school year. A total of about 2,500 students visited the Anchor Room for various needs. (Number does not count those who visited that did not sign in for various reasons). Homeless students have access to clothing and toiletries that often act as a barrier to active school participation.

**Mohonasen Food Pantry:** Bradt and Mohonasen High School have a version of a Food Pantry. The High School partners with Regional Food Bank to fill the bags. The average price per student per week is \$5.63. The average yearly price per student (30 weeks) is \$169. Homeless students will have access to the food pantry at all times.

The Resource Navigation Program is housed at our Mohonasen district office once a week on Thursdays throughout the 2021-2022 school year when school is in session. We are excited about our partnership with SCAP as we continue to enhance our ability to support the various needs of our students, families and school community. SCAP can provide families with assistance free of charge with the following; access to emergency housing, food, clothing, household furnishings and other resources, assistance with applications for public assistance, SNAP, SSI/SSDI, and Home Energy Assistance Program (HEAP), advocacy with DSS and National Grid, and assistance with mediating disputes between tenant and landlord. Families that are homeless will have access to community based organizations at the district. This helps with the barrier of accessing these services by providing opportunities to meet at the district.

Schenectady Connects: Summer Jobs, employement readiness, resume development, interest inventories: Schenectady County Connects is the workforce entity that encompasses Schenectady County Job Training Agency (SJTA) and the New York State Department of Labor One-Stop Career Center/American Job Center which provide universal access to the community to promote self-sustainability and economic growth through a skilled, quality workforce.
