<u>Communications -</u> Superintendent

Mr. Chandler gave the Board an overview of current High School goals. Goals for the 2023-2024 school year include the following: academics: raise expectations and improve academic achievement; culture and climate: establish a safe and secure environment that facilitates growth through the development of body, mind and character; fully prepared graduates: align curriculum, instruction, and professional development to support The Portrait of a Mohonasen Graduate initiative. Mr. Chandler noted that he would like to see every student involved in an extracurricular activity and that staff are able to propose new clubs to meet student interest.

Mr. Shine added that this year has been the best school opening they have ever had and they are seeing progress in every single area. Mohon continues to rise to every challenge, nothing is impossible.

<u>Public Privilege of</u> the Floor

Mr. Abbott read a statement outlining guidelines for those speaking to the Board.

Members of the community and students addressed the Board on a variety of concerns. The following people spoke during Public Privilege of the Floor: Matt Robbins, Rebecca Pollick and Elizabeth Lewis.

Mr. McFarland addressed a statement he made in March and the ongoing concerns regarding it. He made it clear that he supports the LGBTQ+ community and they are welcome at Mohonasen. He said that his original statement was not intended to offend anyone and was misconstrued because of specific word choices that he now regrets. After explaining this, he urged those with concerns to now move forward productively.

Mr. Abbott made announcements regarding NYSSBA training opportunities, the upcoming NYSSBA convention and added that it was a privilege to welcome back the staff and faculty on the District's Opening Day.

Mrs. Power asked for an update on the process for changing Mohonasen's team name and logo. Mr. Shine said he is in the process of getting initial quotes for sign changes or updates and larger projects like the turf field and gym floors. He will be putting out a communication to the community by the end of the week.

The Board also discussed updating policy 1510 to reflect these changes.
